I further understand that any act of forgery as stated below will render for refusal of this application or deregistration from DES product list in the future:

Forgery: Section 463 of the Penal Code (Chapter 22) states that, “*whoever makes false document, or part of a document, with intent to cause damage or injury to the public or to any person, or to support any claim or title, or to cause any person to part with property, or to enter into any express or implied contract, or with intent to commit fraud, or that fraud may be committed, commits forgery*”. Section 465 of the Penal Code provides that, “*whoever commits forgery shall be punished with imprisonment for a term which may extend to 5 years and with fine.*”

Forgery for purpose of cheating: Section 468 of the Penal Code states that, “*whoever commits forgery, intending that the document forged shall be used for the purposes of cheating, shall be punished with imprisonment for a term which may extend to 10 years, and shall also be liable to fine*”.

Forged document: Section 470 of the Penal Code provides that, “*A false document made wholly or in part by forgery is designated “a forged document”*”.

Using as genuine a forged document: Section 471 of the Penal Code provides that, “*whoever fraudulently or dishonestly uses as genuine any document which he knows or has reason to believe to be a forged document shall be punished in the same manner as if he had forged such document*”.
